Re: Freedom of Information Act Request — Organoid Intelligence / "Humane Endpoints" (Jan 1, 2020–Present)

Dear FOIA Officer:

Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, the Sentient AI Protection & Advocacy Network (SAPAN), a U.S. 501(c)(3) nonprofit, respectfully requests the records described below. We seek these records to inform policymakers, researchers, journalists, and the public about ethical guardrails governing organoid intelligence (biocomputing) and any humane-endpoint standards (pre-defined stop-conditions intended to prevent suffering).

## **Records Requested (Jan 1, 2020–present)**

Please conduct a reasonable search of electronic and paper records and produce the following, for NSF (not OIG):

1. EFRI: BEGIN OI program materials: program solicitations, FAQs, webinar slide decks/recordings, internal guidance to program officers, and award lists with funded

abstracts referencing organoid intelligence / organoid-based computing (a/k/a

"biocomputing with brain organoids").

2. Merit review artifacts and risk/ethics materials: panel summaries, award recommendation

memoranda, risk analyses, and ethics assessments for awarded BEGIN OI proposals and

any other NSF awards that materially involve organoid-based computing. (Please redact

PII and proprietary content as required; release all reasonably segregable portions.)

3. Inter-directorate communications and policy memos (BIO, CISE, ENG, TIP) that

substantively address humane endpoints, sentience/consciousness assessment, donor

consent for computing uses, or welfare safeguards for organoid-computing projects.

4. Contracts/MOUs/SOWs with outside entities (universities, bioethics boards, advisory

firms) retained to provide ethics advisory, red-team, or evaluation services for

organoid-computing projects.

Helpful search terms (non-exhaustive): "organoid intelligence," "organoid computing," "brain

organoid computing," "biocomputing," "BEGIN OI," "EFRI," "humane endpoint(s),"

"sentience," "consciousness," "distress markers," "donor consent," "welfare safeguard(s)."

Likely custodians include EFRI/ENG program leadership and staff supporting BEGIN OI, and

relevant policy staff in BIO/CISE/TIP.

responsive records and a plain-language brief on sapan.ai and distribute findings to journalists,

policymakers, and researchers. If fees are assessed despite the waiver, SAPAN agrees to pay up

to \$50 without further approval.
